#### MEMBERSHIP UPDATES

Our membership over the last couple years has dropped to 117. At the end of 2021 we were at 130. We would like to turn this around, which means: **We Need You!** Our best recruitment has been with one-on-one personal invitations to those you may know or meet. I also send out invitations to MOAA members in the area that are provided to me by MOAA National, but this is limited to only a few, if any, MOAA members per month. Only those MOAA members who elect to be contacted, or new MOAA members to the area, are provided to me; so it is really important that we advertise ourselves well and personally invite other former or retired officers to join us. What can you tell someone who may be interested?

- 1) We are the local chapter of MOAA. MOAA has a strong legislative voice in Washington DC. They are working hard for veterans. Their efforts include advocating for pay raises, the repeal of the Death Indemnity Compensation offset for surviving spouses, protecting TRICARE benefits, the PACT Act (comprehensive toxic exposure reform expanding care and benefits), GI Bill upgrades, defeated the 'COLA minus 1 Percent' legislation which would have diminished by 1 percent any cost-of-living (COLA) adjustment for military retirees until age 62. (This saved an E7 \$83,000 and an O5 \$124,000 by age 62, and the list goes on.)
- 2) We work to support veteran organizations in the northeastern Wisconsin area by raising money for veteran support groups. Our annual golf tournament raises tens of thousands of dollars for local area veterans.
- 3) If you desire, we will connect you with MOAA for a free MOAA Basic membership. (You do not have to join MOAA to join our club.)
- 4) Join us for the camaraderie of fellow officers and their spouses. Enjoy some social time together with us. Do you enjoy it? Please share that enjoyment. This may be the most important part of your personal invitation.
