### "The Final Chapter"

This is not normally what a Legislative Board Member would submit to the editor. My wife and I have done some funeral planning and noticed how many of our friends have left the hard decisions to their survivors. Many legal decisions are often overlooked or not communicated. Here is a reminder to our members and a short summary of an article in MOAA's <u>Military Officer</u> from April 2023.

According to estate planners, it's never too late to gather the crucial details by ensuring correct names on every account and asset, mortgages, vehicle titles, and financial accounts. Funeral homes are very helpful in obtaining death certificates and contacts to be made like, Defense Finance and Accounting Service (DFAS) and Defense Enrollment Eligibility Reporting System (DEERS).

The article by Patricia Kime who is a military health care reporter gives many tips on which DOD departments assist with benefits and insurance. She also explained how a recently married Army wife was left without any benefits because her husband had failed to change the new marriage partner information on survivorship with DoD.

Info to have on hand: Will and legal documents, power of attorney, insurance policies, DD214 or letter of retirement, birth certificates, divorce decrees, Social Security numbers or cards, listing of financial accounts, passwords listing of real estate deeds, automobile titles, income tax returns for past 5 years, adoption/naturalization papers, most recent retiree account statement from DFAS, location of medical and dental records. Key phone numbers and a survivors checklist are also essential to the file folder of these plans.
